- Ordinance amendment to allow alternative paving materials and exempting some uses from the requirement to provide paved parking – no speakers
- Ordinance amending the definition of commercial kennels and adding a definition for private kennels – no speakers

## PUBLIC ADDRESS

One speaker criticized the School Board's budgeting process.

## CONSENT AGENDA

- Fire and rescue – FEMA grant appropriation – approved 7-0
- Resolution concurring with the Planning Commission that the proposed new APCO power line in the County is in accord with the 2025 Comprehensive Plan – approved with one abstention (Tuck)

## OLD BUSINESS – Approved 7-0

- Increasing the income limit to \$51,000 for tax relief for the elderly and disabled
- Ordinance amendment – joint tourism program

## NEW BUSINESS – Approved 7-0

Human Resources – appropriation for health insurance consultant

## WORK SESSION

Presentation on pros and cons of amending the County zoning ordinance to allow chickens in residential districts under certain restrictions– the Board agreed to send this issue back to the Planning Commission for review
