1. AFD #14 (Fishers View) Renewal

District #14 (Fishers View) is generally located in the south eastern portion of Montgomery County and is in the vicinity of Alleghany Spring Rd. (Rt. 637) and Fisher's View Rd. (Rt. 609). This district is currently under review for another eight year term. Currently, AFD 14 consists of 2 property owners and approximately 481.925 acres. The proposed new district would consist of 2 property owners and approximately 531.85 acres. (The AFD Advisory Committee has recommended this district be renewed for a term of eight (8) years).
