**Proposed Ordinance Amending the Use of the Central Absentee Voting Election Precinct by Providing for a Central Absentee Voting Election Precinct in all Elections.**
  
2. Rezoning Request - Thomas A. & Penny L. Taylor and Charles A. & Margaret Taylor  
**A request by Thomas A. & Penny L. Taylor and Charles A. & Margaret Taylor to rezone approximately 2.3 acres from Agriculture (A-1) to Residential (R-3), with possible proffered conditions, to allow residential single family dwelling. The property is located on the East Side of Cascades Road 500 feet southwest of the Mid Pine Rd/Cascades Rd intersection. This request has been withdrawn by the Applicant.**

5. Special Use Permit – Charles Lewis Wheeling (Agent: NTelos) – Telecommunications Tower
