Eastern Montgomery High School

Old Shawsville Middle School Fields



Parks & Recreation uses the softball and baseball field and provides field maintenance.

Shawsville Middle School



Parks & Recreation uses the football field for practice for eight weeks. They cut the grass and mark the field for practice. The baseball field is used and maintained by Day Spring Academy for their baseball program.
